- **1.13) Duties & Taxes**:The standard HS Code of packaging machine is **84224**000. Custom duties, excise duties, handling charges, cost of storage at ports are in customers accounts.
- **1.14) Insurance**: Unless otherwise instructed, will dispatch goods to the destination named by the risk and uninsured. accept no liability for damages in transit.
- **1.15) Validity**: Quotation is valid for 60 days from its date..
- 1.16) Payment:
 - **1.161) OPTION A**: 50% advance along with order and balance 50% at least two week before shipment of machine from our works.
 - **1.162) OPTION B**: 30 % advance along with the order from buyer's Bank Account and balance 70 % against irrivocable confirmed non negotiable. LC payable at sight. (Please get the draft of LC approved)
 - If Paying Party is different, then Buyer needs to provide valid document on Company Letterhead quoting relationship between Buyer and Paying Party.
 - Any post custom clearance & delivery, charges of installation / commissioning or other costs are not acceptable.
 - All costs arising due to clauses mentioned herein, unforeseen, to be borne by Buyer.
- 1.17) Delivery: 120-140 days from receipt of technically and commercially clear PO with advance amount /LC copy


